

# The Zero Fee Transfer Offer Code Promotion

## Terms and Conditions:

- To be eligible for the Zero Fee Transfer Offer Code Promotion ("Promotion") you must redeem the respective zero fee transfer offer code via the notification from Remitly that linked you to these terms or enter the respective zero fee transfer offer code at a "Redeem Offer" or "Apply an Offer" page when signed in to your Remitly account and successfully complete a transfer during the Promotion Period as more fully described in the transfer discount offer code messaging that linked you to these terms (such successfully completed transfer is a "qualifying transfer").

- 0 Fee Transfer Conditions. After you redeem the respective 0 fee transfer offer code for this Promotion, the respective 0 fee transfer will be directly applied to your next qualifying transfer if it is successfully completed during the Promotion Period. 0 fee transfer(s) do not apply to transactions made with credit cards.
