

The Amerika Birleşik Devletleri to Haiti Fee-Free + Discount Transfer Promotion

Terms and Conditions:

- To be eligible for the Amerika Birleşik Devletleri to Haiti Fee-free + Discount Transfer promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer which must be from Amerika Birleşik Devletleri to Haiti during the Promotion Period (a "qualifying transfer").
