

The 德国 Special FX Promotion

Terms and Conditions:

- To be eligible for 德国 Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to 德国.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

The Qualifying Transfer must be Successfully Completed to be eligible for the Special FX Rate.
